ACCENT OF FRANCE - GENERAL CONDITIONS OF SALE

Registration for our holidays implies acceptance without any reservation on the part of participating in these conditions.

Article 1: Scope of Terms of Use

These terms are binding and binding on all participants at our sessions. They are legally not dissociable from the enrolment contract.

Article 2: Age Limit

Least 18 years except for children accompanied by their parents.

Article 3: Contract Formation

The contract is formed only when written confirmation of the order by the customer. The client can not make changes to its original order without the prior written ACCENT De FRANCE.

Article 4: Number of Participants

For programs in the formula group and family / friends: the maximum of 7 persons.

Article 5: Rates

The rates shown on our programs are inclusive and prices are listed on the website. They are expressed in Euros and include accommodation and meals (at the manor but also outside -restaurants during trips-, as well as all costs related to educational activities: courses on site but also during visits (entrances to museums, visits to castles etc..) Only personal purchases (souvenirs, etc..) remain the responsibility of interns.

Rates do not include transportation from the country of origin, changing the organization of local transport, any costs for obtaining visas, extraordinary expenses resulting from events which ACCENT OF FRANCE can not be held responsible.

For courses for companies, prices are net of VAT.

Article 6: Registration

Any such entry to be final, must include the completed entry form, dated and signed, with photo ID and must be accompanied by a corresponding regulation at 30% of the total cost at the latest 8 weeks before the beginning of the session chosen. The balance is due 30 days before the start date of delivery, otherwise ACCENT OF FRANCE reserves the right to cancel the booking (unless otherwise agreed individually negotiated and stipulated in the quotation)

Article 7: Accommodation

Advisable on the place of training for educational reasons explained in the "pedagogy.

Article 8: Amendments

If unforeseen circumstances prevent the conduct of the program announced ACCENT OF FRANCE will make every effort to ensure, wherever possible, continuity of the teaching session, including if necessary by changing the composition of the groups listed and proposed visits.

Article 9: Report of Session / Cancellation

A possible cancellation must be received by letter:

Beyond 30 days before the scheduled date: 100 € fee will be withheld.

Cancellation fees:

Between 30 and 15 days ahead of schedule: 50% of total stay.

Between 14 and 3 days ahead of schedule: 75% of total stay.

Less than 48 hours before the scheduled date: 100% of the total stay.

From the 1st day of session or in case of come back in advance , no refund is available.

ACCENT OF FRANCE reserves the right to cancel a session:

In the presence of events or serious circumstances such as to prevent the progress of the program in the conditions there.

The cancellation decision will be communicated to registered not later than 21 days before the start of teaching sessions.

In case of cancellation decided by ACCENT OF FRANCE, affected members may either request a refund of the session or request transfer of registration on another session with availability, at the same price and conditions .

Any refund request must be made by a person whose stay has been vacated by ACCENT OF FRANCE, and refunds will only be granted to the person or organization who paid the price of the stay.

Article 10: Insurance

ACCENT OF FRANCE is covered by insurance for professional liability with an approved group.

ACCENT OF FRANCE remember that people of foreign nationality registered for courses not covered by the French legislation on social protection, unless they are resident in France for at least three months.

Participants in our courses must ensure that they have personal insurance or social insurance covering at least the risk accidents, sickness, maternity assistance and repatriation for the duration of teaching sessions and apply to all proposed activities (educational, cultural or recreational).

It is also recommended that participants enrolled in our courses have a liability insurance covering all activities.

We also inform the participants in our teaching sessions that they can take out insurance covering certain risks of cancellation of trips.

Article 11: Formalities

ACCENT OF FRANCE does not provide transport to return the country of origin. Only the transfer: La Rochelle airport or TGV station to the place of training is provided by ACCENT OF FRANCE. Participants must be in possession of all documents required by the French authorities (identity card or passport). Anyone could not participate in the stay because of the failure to produce relevant authorities of identity documents, entry visa or other required documents will not be entitled to any refund.

Article 12: Certificate of training course

A personal training certificate stating the title of the training and dates of beginning and end is issued after the session. Upon request, the certificate may specify the number of hours worked and / or level achieved.

Article 13: Force majeure

Cases of force majeure, whether they are a temporary or permanent obstacle to the execution of the contract, suspend or extinguish the right bonds ACCENT OF FRANCE on this contract and release ACCENT OF FRANCE of all responsibilities or any damages that may result.

Article 14: Law applicable to the contract and jurisdiction in disputes

Contracts for registration teaching sessions provided by ACCENT OF FRANCE is entirely subject to French law. Any dispute will be brought before the French court of jurisdiction to which the seat ACCENT OF FRANCE, also in accordance with the rules of jurisdiction to award the French law on the nature of the court.

Article 15: Payment

You can pay by bank transfer in EUR on our bank which reference is given below. In this case, we send an absolutely clear photocopy of the transfer order. Please note that bank charges on remittances or cards are charged to the customer.
